tips, skills and strategies amidst a pandemic. She has over 12 years of industry experience and unique insights into what is required of candidates.


Barrister Sarah also covered regulatory bodies, companies and law firms as potential employers in her presentation.

3. The Perils of Social Media: Mental Health & Diminishing Space | 20 June 2020



On Saturday, 20th June 2020, Lahore Education and Research Network (LEARN) hosted an inhouse discussion on 'The Perils of Social Media: Mental Health and Diminishing Space'. The discussion was organised with support from Barrister Jugnoo Kazmi who is the Women in Law Initiative Pakistan's (WIL) Chapter Lead in Islamabad.

The participants for the discussion included, Ms. **Valerie Khan** Executive Director of Group Development Pakistan, Ms. **Zoe Richards**, lawyer and women's rights activist, Ms. **Elaine**

Alam, General Secretary, Faces Pakistan, Mr. Hisham Khan from Pakistan Youth Change Advocates, Ms. Umaima Tahir Wadood, journalist and online blogger, Ms. Ramla Baig, advocate, Barrister Maryam Salman, Ms. Asha Singhania, WOZA - Women in Law South Africa, Ms. Jannat Ali Kalyar, Cyber Laws and Digital Security practitioner, Ms. Zeeba Hashmi, peace education consultant, Ms. Eamaan Bandial, advocate, Imaan Mazari, advocate, Barrister Ayesha Siddique Khan, advocate and gender rights activist, Ms. Benazir Jatoi, advocate, Mahnoor Waqar, advocate, Fatima Awan, HR Executive Getz Pharma, advocate Maimana Khattak and advocate Noor Mandvivala.

The discussion was moderated jointly by Ms. **Nida Usman Chaudhary**, founder LEARN & Women in Law Initiative, Pakistan and **Barrister Jugnoo Kazmi**, WIL- Islamabad Chapter Lead.

The discussion aimed to look at some of the perils of social media and to take stock of how those may affect different vulnerable groups particularly in the context of their diminishing space and freedom of expression as well the mental health implications of the online violence and abuse.



One of the leading questions under discussion related to the politicization of social media and whether that was a factor affecting diminishing online space and creating mental health implications.

In recent years, the use of social media has been revolutionized and there is increased reliance on digital tools and platforms to do business, access education and to communicate with one another. The COVID-19 pandemic has further exacerbated the dependence on technology and therefore, the harmful impacts of social media can very easily target women, children, minorities, mothers, youth, certain professionals and the elderly in their own respective ways.

The participants endeavored to identify the different sets of perils each class of persons was likely to face in their online engagement and interaction and put forth the challenges faced by lawyers, concerned authorities, and regulators in relation to creating a balance between competing rights and interests and in regulation, if any.

The question of who should regulate and how was also discussed as were the many perils that are associated with the regulation of use of social media.



4. Stranded Spouses – Follow up Session with BETI | 26 June 2020



5. Webinar on Statelessness in collaboration with Imkaan Welfare 8 July 2020

Imkaan Welfare Organization in association with Women in Law Initiative Pakistan conducted an online session for women in law on the position and plight of the stateless community in Karachi, with a particular focus on the stateless residents of 'Machar Colony' – an informal settlement in Karachi largely comprising persons of Bengali ethnicity.

Many of them do not have national identity cards which makes them stateless with far reaching social, economic, legal and political consequences.

One of the aims of Imkaan's projects is to raise awareness regarding the issue of statelessness and its consequence of creating a new form of marginalized community. This session titled, "within the state, without identity: statelessness in Pakistan" was one such step in that direction.

8. Legal Profession for the Many? | 9 Aug 2020


An online session adopting a critical review of the legal profession and its structure from the context and position of young lawyers was conducted. Largely unregulated, primarily unaccountable, the legal profession leaves much to be desired for mainstreaming entrants into the profession.

The speakers included, Hassan A. Niazi, Ali Abbas Mansoor, Dania Mukhtar, Noor Bano Khan and Moiz Baig.

They raised issues of lack of pay structures, clear career progression and lack of accountability mechanisms.

The panelists also looked at the challenges in the profession from a gender lens and highlighted the specific issues faced by young women.

9. Increasing Women's Representation in Law - Project Launch 3 Sept 2020



Increasing Women's Representation in Law is a flagship collaborative action curated by Women in Law Initiative Pakistan and supported by Federal Ministry of Law and Justice, Australian High Commission and British High Commission. It is implemented with institutional support from Group Development Pakistan.

Under this project, for the first time, a public-private partnership to mainstream gender equality in the legal profession as well as to ensure equal representation of women and visibility for their work and contributions was highlighted. The project outcomes included:

- i. Instituting Pakistan's 1st Women in Law Awards honoring female legal professionals and entities performing well on gender and diversity index in over 22 categories;
- ii. Symposium leading to public of Pakistan Journal of Diversity and Inclusion on Increasing Women's Representation in Law
- iii. Baseline study on state of Women's Representation in Law (available here: https://www.lawyher.pk/Uploads/Status-of-Women-Representation-in-Law-2020-21.pdf)
- iv. Development of a one-stop digital portal and mobile app (<u>www.lawyher.pk</u>) for an on women in law.








14. #16DaysOfActivism - Women & Inclusive Leadership - in collaboration with Ananke Digital Magazine | 26 Nov 2020

15. Online Legal Training Programme - Covid and GBV - in collaboration with Acid Survivors Foundation, Group Development Pakistan - supported by European Union | Oct-Nov 2020

A seven-part online training session was organized for lawyers and shelter home personnel for addressing and handling gender-based violence cases amidst Covid crises.

The participants were made aware of the online and digital tools for reporting as well as substantive concepts



such as what constitutes gender-based violence, what is meant by psychological and economic abuse, the legal processes for pursuing cases and the jurisprudence evolving from decided cases.

The evaluation was conducted via a quiz at the end of the seven-part training series and certificates were distributed to eligible and qualified participants. The trainers included, Advocate **Huma Jamil Babar**, **Nida Usman Chaudhary**, **Huma Khan** and **Sohail Akbar Warraich**. **Barrister Jugnoo Kazmi**, Islamabad Chapter lead from Women in Law moderated the sessions. The sessions were managed jointly by Acid Survivors foundation and Women in Law Initiative. Over 100 participants registered for the training session.

16. Child Protection and Safe Campuses - Study 10 Dec 2020

On <u>#HumanRightsDay</u>, we launched our joint-study with Faces Pakistan on institutional reforms needed for child protection from abuse in schools and colleges to mark the culmination of <u>#16days</u> of activism to end <u>#GBV</u>. Education is a fundamental right and every child must be able to access it in a safe and participatory fashion to <u>#RecoverBetter</u>.



The study was a result of over six months of consultations and research. It is authored by **Nida Usman Chaudhary**, LEARN, and **Elaine Alam**, Faces Pakistan.

Victims of trafficking are often then subjected to forced prostitution, slave labour etc. Amy spoke about the prevalence of international trafficking, preventative methods and how Stop the Traffik tackles this crime.


17. Speaking Engagement – Lahore School of Law | 8 March 2021
